

2019 Miss LaGrange County Pageant Guidelines

- ❖ Contestant must never have been married or have had children.
- ❖ Contestant must reside in LaGrange County and/or be involved in LaGrange County 4-H.
- ❖ Contestant must not get in trouble with the law as an applicant of the queen contest or when crowned Miss LaGrange County or Miss LaGrange County Queen's Court. If so, you will be disqualified or your title will be taken and all awards given will be forfeited.
- ❖ Each contestant must be at least 18 years of age and cannot have reached their 22nd birthday on or before June 1, 2019.
- ❖ Contestant will be judged in the categories of Interview, Professional Wear, Evening Wear, and stage presence during group number and must therefore possess attire sufficient for each category.
- ❖ Contestant must have all apparel being worn during the pageant approved by the pageant committee.
- ❖ Contestant is not allowed to have family or friends behind the scenes during the pageant. Assistance will be available.
- ❖ Contestant is responsible for finding a sponsor for herself (a local business, relative, etc.)
- ❖ Contestant will be responsible to submit a \$100.00 sponsorship fee from her sponsor/s. Up to two sponsors can split \$100.00 sponsorship fee.
- ❖ Miss LaGrange county and Queen's Court will all participate in the 4-H Fair Parade on Sunday, July 14th and will be responsible for providing a convertible to ride in.
