Youth Representatives are being sought to serve on the Tippecanoe County 4-H Exhibit Association

In 2008, The Tippecanoe County 4-H Exhibit Association made revisions to their constitution and by-laws to bring youth to their boardroom. They are continuing this process and are seeking applicants to serve a two year term starting in 2020. The youth who are selected to serve have the opportunity to gain a greater understanding of the details involved in hosting a fair. It also allows young people to interact with members of the Exhibit Association and share a youth perspective as they work to plan and host the Tippecanoe County 4-H Fair.

Currently, the Tippecanoe County 4-H Exhibit Association is recruiting applicants for the year ahead. Applications will be due **January 31, 2020** and will be followed by an individual interview with members of the 4-H Exhibit Association. Applications are welcomed from Tippecanoe County 4-H members enrolling in their 8th, 9th, or 10th year of 4-H in 2020 and who have an interest in getting involved with a community-oriented group.

To apply, interested young people should complete the attached application; including a recommendation form completed by a teacher, coach, or adult mentor. Selected applicants will be invited for an interview. *Application does not guarantee an interview or a position on the 4-H Exhibit Association.* Application materials are due by **January 31, 2020**. Applications can be submitted via mail, to **Tippecanoe Co. 4-H Exhibit Association, P. O. Box 4466, Lafayette, IN 47903**.

Those selected to serve as youth representatives on the board will be expected to attend the 4-H Exhibit Association meetings on the third Monday evening of each month. (If you cannot attend meetings regularly due to your academic schedule, but are still interested, please apply.) Youth Representatives will also be expected to actively participate alongside Tippecanoe County 4-H Exhibit Association members as they plan, and host the 2020 Tippecanoe County Fair (July 18 – 25th).
